If no response requiring further consideration (for example contesting the information from the Government) is received by the Working Group from your organization and/or the families within a period of six months from the date of this letter, this case will be considered clarified, therefore no longer under the consideration of the Working Group. It was reported that on 21 August 2007, Mr. Lobsang Thokmey (Lothok), was arrested at the Wu Hou Si Guesthouse, Ganzi bing guan, Er Huan Lu, in Chengdu, Sichuan Province, China, by the Chengdu Public Security Bureau and Police. The subject was reportedly arrested in connection with a political protest in his hometown of Karze. No action was taken to locate him because of fear of reprisals. His fate and whereabouts remain unknown.

"Lobsang Thokmey, male, 36 years old, ethnic Tibetan, herder from Laza village in Benge rural township, Litang county, Garzê prefecture, Sichuan province. On 20 August 2007, Lobsang Thokmey was taken into criminal custody by the Chengdu city public security authorities on suspicion of having conducted activities that endangered State security and, on 8 September, he was handed over to the Garzê prefecture public security authorities. On 15 September, in accordance with the provisions of article 111 of the Criminal Code of the People's Republic of China, his arrest was approved by the Garzê prefecture people's procurator's office and he is currently being held in the Garzê prefecture detention centre."
