Pursuant to my case submission regarding the arbitrary detention of Mr. Kelsang Gyatso on 13 April 2009, I wish to inform the Working Group about the safe arrival of five Tibetan monks from Labrang County, China, out of which three monks were colleagues of Mr. Kelsang Gyatso who had participated in the media briefing on 9 April last year. The three monks who managed to escape from Tibet is gravely concerned about the safety of their colleague Kelsang as he will be subjected to torture during his arbitrary detention by the County Public Security Bureau.

The Tibetan Centre for Human Rights and Democracy (TCHRD) seeks your urgent intervention in the case of arbitrary detention of a 36-year-old Tibetan monk, Kelsang Gyatso, who was arrested on 13 April 2009 while travelling from Xiahe County in Gansu Province to Tsoed City in Kanlho, China.

Kelsang was wanted by the Xiahe County Public Security Bureau for his participation in a group of monks' defiant briefing to a government managed tour for a media group to the Labrang TashiKhyil Monastery in Xiahe County, Gannan "Tibetan Autonomous Prefecture", Gansu Province on 9 April 2009. The sudden display of emotions and defiant briefing by the monks caused much embarrassment to the authorities. Two monks from the group were dissappeared involuntarily within days after the incident by the authorities and they are reported to be missing till date. Many monks left the monastery to escape arrest. Kelsang too left the monastery.

However, after several months in another location Kelsang had to return to the Labrang Monastery upon hearing about his uncle's grave health conditions. Despite his best efforts, his uncle passed away. On 13 April 2009, while he was travelling from Xiahe County to Tsoed City in a bus, he was picked up a group of police officers waiting for him on the road. He is currently known to be in Xiahe County Public Security Bureau Detention Centre. Please find

The TCHRD fears that the authorities will torture and perhaps also eliminate him for the 9 April 2009 incident that had caused major embarrassment to the government. Two monks, Thabkhey and Tsundue, have been missing till date and many in the area feel that they have been killed by government agents. A similar fate might also be met to Kelsang Gyatso. The TCHRD appeals the WGAD to immediately send an urgent intervention to the Chinese authorities regarding the arbitrary detention of Kelsang and thereby secure his life also. Beginning from 10 March 2008 Tibetans through out Tibet rose up against the Chines e rule in Tibet. Xiahe County in Gansu Province was one of the area where some of strongest and the most fearless demonstrations were staged by the local Tibetan population on 14 and 15 March 2008. The monks of the local Labrang TashiKhyil Monastery led and participated in the demonstrations in great numbers demanding end

On 9 April 2008, the Chinese government organized a media tour to the area after repeated concerns raised by the international community. Much to the surprise and embarassment to the authorities, when the media group arrived at the Labrang

to Chinese occupation of Tibet.

TashiKhyil Monastery the monks defiantly gave briefings concerning lack of human rights in Tibet. This briefing caused major embarassment to the authorities who faced a similar outburst by the monks during an earlier government managed tour at Jokhang Temple in Lhasa.

In the aftermath of the monks briefing to the media at the Labrang Monastery, two monks, Lobsang Thabkhey and Tsundue, have been dissappeared involuntarily by the authorities and they are reported to be missing till date. Several other monks from the monastery fled to other areas to escape arrest by the authorities. Kelsang Gyatso too left the monastery and lived in an undisclosed location for several months. However, he had to come back to Xiahe County when he learned that his uncle at the monastery was seriously ill. Despite his best attempts, his uncle passed away.

On 13 April 2009, Kelsang while travelling to Tsoed City in a bus was picked up on the way by a group of police officers waiting for him.
